

# State of Idaho January 2008 Point-in-Time Count Report

HUD requires a biennial point in time count of sheltered and unsheltered homeless persons across the country. The following report is the results of Idaho's statewide one-night Point-in-Time Homeless Count conducted on January 30, 2008.

In accordance with HUD's definition of homelessness, a person is considered homeless only when he/she resides in one of the places described below at the time of the count:

- Unsheltered homeless person resides in a place not meant for human habitation. Included in this count are people in temporary tents or armory shelters, encampments, and warming centers.
- A sheltered homeless person resides in an emergency shelter, transitional housing or supportive housing for homeless persons who originally came for the streets or emergency shelters.

*This definition of homelessness does not include persons who may be staying with friends or relatives, in a hotel/motel, in a treatment facility or in jail. Persons in these circumstances are defined as "Precariously Housed" and are often characterized as being at imminent risk of becoming homeless.*

## Summary of Survey Results

- 1464 sheltered and unsheltered individuals and persons in households counted as homeless
- 774 single individuals and 258 Households of two or more persons
- Of persons who identified gender, 57% male and 43% female
- Of persons who identified age, 26% are under the age of 18
- Of persons who identified Disabling Condition, 26% suffer from substance abuse and 13% from Mental Illness
- Of persons who identified , 12% are Veterans and 22% are victims of Domestic Violence
- 205 Precariously Housed individuals or households were surveyed during the unsheltered portion of the count but are not included in the final count numbers

The Point-in-Time Count consists of two methods to collect data for the night of Wednesday, January 30, 2008. The sheltered homeless data is collected from surveys filled out by the shelters and from the statewide HMIS database. The unsheltered homeless survey is administered by "street" and "service based" counts conducted in each region in the state and entered into HMIS.

A Chronically Homeless Person is defined by HUD as:

- An unaccompanied homeless individual with a disabling condition who has either been continuously homeless for a year or more OR has had at least four episodes of homelessness in the past three years AND.
- The homeless person must have been sleeping in a place not meant for human habitation (e.g. living on the streets) and/or in emergency shelter at the time of the count.

*Note: HUD's definition of the chronically homeless does not include persons in families/households.*
